We practice vegetable tanning in our leather production in accordance with DIN EN 15987:2015 without the addition of chromium salts. Furthermore, we use sustainable materials for our linings, consisting of organically grown cotton and recycled polyester.

We have also been a member of the Leather Working Group (LWG) since April 2021, which means that our entire fall /winter 2025 collection is LWG-certified.
